DUE PROCESS HEARING ISSUES

1. Failure to comply with provisions set forth in Part B of the Individuals with Disabilities Education Act (IDEA). Specifically, by failing to provide a free appropriate public education (FAPE) (S)

COMPLAINT INVESTIGATION ISSUES

C-20-14

1. that the District failed to develop and implement an appropriate IEP for the Student to allow for meaningful progress (S)

C-20-15

1. that the District failed to develop and implement an IEP for the Student that is reasonably calculated to allow for meaningful progress (S)
2. that the District did not consider parental input for development of the IEP (NS)
3. that the District failed to provide a Parent copy of Procedural Safeguards (NS)
